SPOTLIGHT ISSUE - Hepatitis

Hepatitis C is a serious health issue.

- It affects the lives of over 58,000 Queenslanders.
- 90% of hepatitis C notifications, and 50% of new notifications for hepatitis B, occur amongst people who inject drugs (PWID).
- Many of our clients no longer use drugs. But as they have aged and began to have more serious health issues, they have found out about their viral hepatitis.

Hepatitis Queensland offers a range of services to people affected by hepatitis, as well as the staff of other organisations directly involved with people who may have, or be at risk of, hepatitis. HQ offer comprehensive and free 'ABC of Hepatitis' education sessions, free clinical counselling by a registered psychologist, as well as providing a 9-5pm information and support phone line (free call 1800 648 491).

This is the first in a series of six guides, with the others to follow in the coming weeks and months.

Australia21 Report... a conversation starter

The release of Australia21's latest report on 3 April 2012, <u>The prohibition of illicit drugs is killing and criminalising our children and we are all letting it happen</u> generated national media interest.

The report was the outcome of an Australia21 roundtable on drug law reform held at the University of Sydney in January 2012. QNADA has not issued an official response to the report recommendations however agrees with ADCA that it is beyond time that a sensible discussion is had about the balance between law enforcement/ policing focus and harm minimisation.

DoHA Flexible Funding Rounds from 1 July 2012

On 13 April 2012, all AOD peak organisations wrote to Minister Butler to express concerns regarding the delays. NADA has spoken with Minister Butler and his advisor to stress the concerns of the sector in the delayed announcement of the NGOTGP and Substance Misuse Flexible Funds. Services will be contacted by the Queensland DoHA officers to advise if they have been successful or not. We have been advised that notification will be out in the next week.

QUEENSLAND GOVERNMENT UPDATE... Changes afoot

On 30 March 2012 the Queensland Government announced machinery-of -government changes for departments. The functions of the former Department of Communities will now be delivered by the following departments:

The new Alcohol Advertising Review Board was launched on 16 March 2012. This new national body will review alcohol advertising in Australia to counter the out of control advertising and marketing of alcohol, linked to increasing levels of alcohol-related harm.

The Board will consider and adjudicate complaints from the community about alcohol advertising, providing an independent alternative to the self-regulation system. The Board is strongly supported by QNADA, ADCA and other major health groups across Australia. Any member of the public, or frontline workers in the sector, are invited to direct complaints about alcohol advertising to the Board.
